In these Terms, the following words and expressions have the meaning as set out below:

Controller, Personal Data as defined in the Data Protection Legislation

Data Protection Legislation all applicable data protection and privacy legislation in force from time to time in the UK including the UK GDPR; the Data Protection Act 2018 (DPA 2018) (and regulations made thereunder) and the Privacy and Electronic Communications Regulations 2003 (SI 2003/2426) as amended and all other legislation and regulatory requirements in force from time to time which apply to a party relating to the use of Personal Data (including, without limitation, the privacy of electronic communications); and the guidance and codes of practice issued by the Information Commissioner or other relevant regulatory authority and applicable to a party.

Installation

You are responsible for installation of the 4G Dashcam product and ongoing maintenance of the 4G Dashcam product, including but not limited to installation in accordance with the installation terms as set out https://www.rewiresecurity.co.uk/installation-terms which are deemed to be incorporated into these Terms. If you do not comply with those terms we shall not be liable for any loss you incur.

It is your responsibility to make sure that the location of the 4G Dashcam product in the vehicle is fitted in the way it complies with the local laws and government regulations. The 4G Dashcam product should never be installed in the way it obstructs the drivers view or otherwise interferes with the safe use of the vehicle in which it is installed.

Please note that whilst the 4G Dashcam products are legal to use in the UK, in other parts of the world they may not, and dash cam use may result in heavy fines. It is your sole responsibility to be aware of local laws and regulations in respect of use of dash cam products and you must satisfy yourself that you are lawfully able to purchase the 4G Dashcam products and/or services. You need to be aware that if you take your vehicle into another jurisdiction, you may not be able to lawfully use the 4G Dashcam in that jurisdiction. We accept no liability for any costs, losses or damages resulting from or related to the purchase or attempted purchase of the 4G Dashcam products and/or services by persons in jurisdictions outside the UK.

Recordings

If you use 4G Dashcam products in UK, you always must comply with the Data Protection Legislation. For example (but without limitation), it is your sole responsibility to:

- a) inform people that they are being recorded;
- b) make people in and around the vehicle aware when you switch on the audio record function. Please note that it is strongly advised to only enable this feature with consent or when strictly necessary.
- c) keep safe any personal data that is collected, used or shared that can identify someone;
- d) delete any footage when you no longer need it, for example if there hasn't been an accident, and there is no other reason to keep the footage, it should be deleted after a week or so.
