GPSTLive is committed to protecting the privacy of its customers. We will only use the information that we collect about you lawfully (in accordance with The EU's General Data Protection Regulation (GDPR)). We collect information about you to process your order and to provide you with the best possible service.

When visitors leave comments on the site we collect the data shown in the comments form, and also the visitor's IP address and browser user agent string to help spam detection. Visitor comments may be checked through an automated spam detection service.

An anonymized string created from your email address (also called a hash) may be provided to the Gravatar service to see if you are using it. If you edit or publish an article, an additional cookie will be saved in your browser. This cookie includes no personal data and simply indicates the post ID of the article you just edited. It expires after 1 day.

We only send promotional email or mail to you with your prior consent and do not pass any of your information to third parties without first gaining your explicit consent.

We will never collect sensitive information about you without your explicit consent, however additional information you may provide us with may be used to personalize your visits to our website.
